INFORMATION SHEET

Scholarships are available for qualifying students, some regardless of their need for financial aid. However, **all scholarship applicants are required to file the Free Application for Federal Student Aid (FAFSA).**

Students wishing to be considered for a scholarship from Eastern Gateway Community College should use the following checklist to make sure their application is complete and processing is not delayed.

- *File the 2019-2020 FAFSA (Free Application for Federal Student Aid). Fill out your free FAFSA at www.fafsa.gov. EGCC School Code 007275. We urge everyone to use the IRS Data Retrieval Process when prompted! 2019-2020 FAFSA can be filed beginning October 1, 2018. We urge ALL applicants to use the IRS Data Retrieval option to save time and reduce the paperwork you may be required to submit!*
- *Scholarship Application (completed and signed)*
 - **Reminder: Hess Scholarship** requires separate application!
 - **Reminder: Senator Lou Gentile Scholarship** requires separate application!
- *High School Transcript/ GED (for new students only)*
- *Essay detailing applicant's career goals and how he or she believes their course of study at Eastern Gateway will further those goals. Also, please state why you feel you are worthy of this scholarship.*
- *Letter of recommendation from Advisor, Faculty Member, Counselor, Clergy*

Priority will be given to applications received by the deadline of March 8, 2019 but applications will be accepted until all scholarships have been awarded.

Scholarships Available for Full-Time Students

ALUMNI SCHOLARSHIP - \$500

Awarded to students entering his/her second year at EGCC. Evaluation criteria for this award include community involvement, motivation to obtain career goals, grade point average and accomplishments. Financial need must be demonstrated. **Four (4) \$500 scholarships will be awarded.**

DEFENBAUGH SCHOLARSHIP - \$500

Eligible candidates must be pursuing an Associate Degree. Must have completed 30 credit hours. Financial need must be demonstrated.

SAMUEL & GRACE H. JOHNSTON SCHOLARSHIP - \$1,200

Awarded to students enrolled in the Engineering or Computer Science programs. Applicants must be working toward an Associate Degree and have a minimum G.P.A. of 3.0 from EGCC or matriculating from their high school. Priority will be given to incoming first time students. Possibility of more than one recipient for this award. If all costs are covered under federal or state financial aid, the student is ineligible for this scholarship.

MEEKS FAMILY SCHOLARSHIP - \$1,000

Applicants must be in good academic standing and must have maintained at least a 2.00 grade point average in high school or at EGCC. The student may be either certificate or degree seeking. Full time enrollment is required (12 or more credits).

STEVEN E. STRUPE MEMORIAL SCHOLARSHIP - \$1,000

Applicants must be a candidate for graduation of the Buckeye Local School District or district that incorporates Buckeye Local should a consolidation ever occur in the year the scholarship application is made. The student must have attained a cumulative grade point average of 3.0 or better at the time the scholarship application is made. The applicant must be pursuing a degree or certificate at the College. Priority consideration will be given to students planning to enroll in an Engineering program.

Scholarships Available for Full or Part-Time Students

JASMINE BABER SCHOLARSHIP - \$250

Applicants of Jefferson County are eligible to apply. The student may be either certificate or degree seeking. Enrollment of 6 or more credit hours is required to receive the scholarship.

CRISS FAMILY SCHOLARSHIP – \$250 (*6 hours minimum)

Applicants must be pursuing an Associate of Applied Business Degree and must have maintained at least a 3.0 GPA in high school or at EGCC. Applicants must be a resident of Jefferson County. Applicants must first apply for all available

federal and state funding. If an applicant has received financial aid to cover all costs, the student would be ineligible for the scholarship.

NANCY & DAVID MILLER SCHOLARSHIP ~ \$500

Applicant must be a Jefferson County resident.

FRANK S. DIMIT SCHOLARSHIP - \$500

Applicants of Jefferson County who are graduates of Steubenville High School are eligible to apply. This scholarship is intended to assist a student who may not be eligible for the Horizon Grant due to a grade point average of less than 2.5 or if the student went directly to another higher education institution and has now returned to EGCC. The student may be either certificate or degree seeking.

Scholarships Available for Full or Part-Time Students

DISPLACED WORKERS SCHOLARSHIP – \$1,250

Applicants must be a resident of Jefferson County and must be considered a displaced worker. A displaced worker is a worker who has been permanently laid off, or has received a notice of layoff or termination from employment due to the company's failure or plant closure. Documentation must be provided with application. Recipient must enroll on at least a half time basis (6 or more credits). \$\$\$ Five (5) \$1,250 scholarships will be awarded. \$\$\$

EGCC SCHOLARSHIP - \$500 (*6 hours minimum)

Applicant must be pursuing an Associate Degree or Certificate with a minimum G.P.A. of 3.0 and have completed 24 credit hours.

EDITH FORESTER SCHOLARSHIP - \$120

Intended for students accepted into the Practical Nursing program, who have established a minimum G.P.A. of 3.0. Student must be a resident of Jefferson County and show financial need after Federal and State funding is applied.

BERKMAN SCHOLARSHIP

Employees or dependents of the Louis Berkman Company will receive first consideration. If there are no Louis Berkman employees or dependents, the scholarships are available to assist other qualified students pursuing an Associate Degree or Certificate at EGCC. Can award up to the amount of tuition and fees for eligible recipient (lesser amounts depending on funding level). If an applicant has received financial aid to cover all costs, the student would be ineligible for the scholarship.

SENATOR LOU GENTILE SCHOLARSHIP –

****There is a separate application for this scholarship.****

Applicant must be pursuing one of the follow programs: Natural Gas Operations, Electro Mechanical Engineering,

Electrical/Electronics, Mechanical, Environmental Science Water and Wastewater or Welding. This scholarship can assist with tuition & fees applied directly to student account. If money available funds can be used to offset books, supplies, etc. Must maintain a 2.0 GPA. Must complete a separate application. (several scholarships can be given out depending on funding)

NINA GENTILE SCHOLARSHIP - \$500 (*6 hours minimum)

Incoming freshmen residing in Jefferson County pursuing an Associate Degree or Certificate with a 2.5 G.P.A. or above documented from an official high school transcript are eligible. Federal and State funding must be applied first. ***Two first-year students will receive this scholarship.***

THOMAS GEORGE SCHOLARSHIP - \$500

2016 Graduating Seniors from Edison High School in Jefferson County are eligible to apply. First priority given to "heirs at law" of Thomas George; recipient may be any other EHS graduate if George heirs don't apply. Must have a cumulative grade point average of 2.5 or above. The scholarship recipient will be selected by Edison High School officials.

GLAUB FAMILY SCHOLARSHIP - \$500

Applicants of Jefferson County are eligible to apply. This scholarship is intended to assist the student with the cost of required books and supplies. The student must be in good academic standing and must have maintained at least a 2.00 grade point average in high school or at EGCC. The student may be either certificate or degree seeking. Enrollment of 6 or more credit hours is required to receive the scholarship.

Scholarships Available for Full or Part-Time Students

HART SCHOLARSHIP - \$300

Available to a Jefferson County resident pursuing an Associate Degree in Accounting. Must be in his/her last semester in the program.

HESS SCHOLARSHIP - \$1,000 (full-time) and \$500 (part-time)

Applicants must have 2.5 GPA or better (high school or college) ***There is a separate application for this scholarship.*** Applicant must see financial aid for a scholarship application OR call financial aid help desk at 1-888-590-9009, option #2 and ask that an application be emailed to you.

KNOX FAMILY SCHOLARSHIP - \$500

Applicants must be a business management major. Two \$500 scholarships will be awarded. One to a student who attends the Jefferson Campus, and one who attends a site in either Columbiana, Mahoning or Trumbull counties.

M & M HARDWARE SCHOLARSHIP - \$500

Applicants of Jefferson County are eligible to apply. The student must be in good academic standing and must have maintained at least a 2.50 grade point average in high school or at EGCC. The student may be either certificate or degree seeking. Enrollment of 6 or more credit hours is required to receive the scholarship.

McCLELLAN TRUST FUND - \$750

Applicants must demonstrate academic success with a G.P.A. of 2.75 or above. Must be pursuing an Associate Degree or Certificate. Must demonstrate financial need. **Up to three recipients may be selected.**

NICKA. MOUGIANIS MEMORIAL SCHOLARSHIP - \$750

Applicants must be a resident of Jefferson County or one of the West Virginia Reciprocity counties (Brooke, Hancock, Ohio, Marshall and Wetzel) and demonstrate academic success with a G.P.A. of 2.00 or above in high school or at EGCC. Must be pursuing an Associate Degree or Certificate. If an applicant has received financial aid to cover all tuition, fees and book costs, the student would be ineligible for the scholarship.

HELEN L. & JAMES F. MURRAY SCHOLARSHIP - \$500

Graduates of Steubenville High School pursuing an Associate Degree at EGCC. Must have a minimum G.P.A. of 2.0.

KIMBERLY J. PATTERSON SCHOLARSHIP - \$250

Applicants of Jefferson County are eligible to apply. This scholarship is for new or continuing students. Applicants must be pursuing an Associate Degree or Certificate. Must have a cumulative grade point average of 2.0 or better at EGCC or from high school. If an applicant has received financial aid to cover all costs, the student would be ineligible for the scholarship.

Scholarships Available for Full or Part-Time Students

THE ANONYMOUS SCHOLARSHIP - \$2000

Applicants of Jefferson County are eligible to apply. This scholarship is for new or continuing students. Applicants must be pursuing an Associate Degree or Certificate. Must have a cumulative grade point average of 2.0 or better at EGCC or from high school. Can be used for tuition and fees. Required books and supplies at the college bookstore.

Two recipients may be selected

LINDA SLOWIKOWSKI SCHOLARSHIP - \$500

Female applicants who reside in Toronto, Ohio in Jefferson County are eligible to apply. This scholarship is open to new and continuing students who have demonstrated financial need (based on FAFSA results). The student may be either certificate or degree seeking.

TRI-STATE FINANCIAL SERVICES SCHOLARSHIP - \$100

Applicants of Jefferson County are eligible to apply. This scholarship is open to new and continuing students who have demonstrated financial need (based on FAFSA results). The student may be either certificate or degree seeking.

WILLIAM & JUANITA WELSH FAMILY SCHOLARSHIP - \$250

Applicants of Jefferson County who are pursuing an associate degree in Nursing are eligible to apply. The student must be in good academic standing and must have maintained at least a 2.75 grade point average at EGCC or at his/her previous educational institution. The recipient must show acceptance into the AAS Nursing Program.

YANOK FAMILY SCHOLARSHIP - \$250

Applicants of Jefferson County are eligible to apply. The student must be in good academic standing and must have maintained at least a 3.00 grade point average in high school or at EGCC. The student may be either certificate or degree seeking. Enrollment of 6 or more credit hours is required to receive the scholarship.

GREGORY AND MARTHA GETT SCHOLARSHIP - \$1000

Applicant must attend the Trumbull or Youngstown location, minimum GPA of 2.5 This scholarship is open to new and continuing students.

MR. & MRS. JOHN DI LORETO & CONNOR MEEKS MEMORIAL SCHOLARSHIP - \$1,000

Applicants must have completed at least one semester of college work and have attained a cumulative GPA of at least 2.5 and must reside within the Edison Local School District. The monies will be directly applied toward the payment of tuition and fees. Any funds remaining will be put on a charge account at the college bookstore for the student to use towards the purchase of required books and supplies. Recipient must enroll on at least a half-time basis (6 or more credit hours).

W. Hunter Vaughan, M.D. Scholarship ~ \$125

Dr. W. Hunter Vaughan established this scholarship in to assist local residents who are pursuing an Associate of Applied Science Degree in Radiologic Technology. The applicant must be a second year Radiologic Technology student in good

academic standing with at least a 3.0 cumulative grade point average. The recipient must be enrolled on at least a part-time basis (six credit hours or more).

Dr. Burnadette M Green Scholarship ~ \$500

This scholarship will be awarded to a student pursuing a certificate in EFDA, who graduated from the College's Dental Assisting Program. The student must have a minimum cumulative GPA of 3.0 and have completed on full semester at the time of application. Two letters of recommendations are required.

American Electric Power (AEP)

Applicants must be accepted to EGCC and enrolled either full-time or part-time. Applicants have attained and maintain a 2.75 GPA each semester. Applicants must be an AEP customer or the son or daughter of a customer. Applicants must be pursuing an academic program related to the electric industry. Applicants must be at 200% household poverty level.

(several scholarships can be given out depending on funding)

Joann Cunningham Memorial Scholarship ~ \$1000

Applicants must be accepted to EGCC and enrolled either full-time or part-time in the Nursing program. Applicants have attained and maintain a 2.75 GPA each semester.

Scholarships Available for ~~Part-Time~~ Only Students

NAYLOR SCHOLARSHIP - \$500

Applicants must be a resident of Jefferson County (Ohio) or Brooke or Hancock County (WV). Student must show academic success in pursuing an Associate Degree with a minimum of 25 credits achieved. Should demonstrate financial need and be involved in activities within the college and in the community. \$\$ **Ten (10) \$500 scholarships are available.**
