An IEP contains a list of "modifications" which are not all suitable for College courses because at that level (College courses rather than high school courses) you have to work within a list of ADA (Americans with Disabilities) "accommodations." What's the difference? Modifications change the course; accommodations help the student access the course like classmates who do not have disabilities, but everyone gets the same course. The student with the disability therefore doesn't get an unfair advantage that changes the course for him or her. The legal language is that an accommodation cannot "fundamentally" alter the course for the student with a disability.
